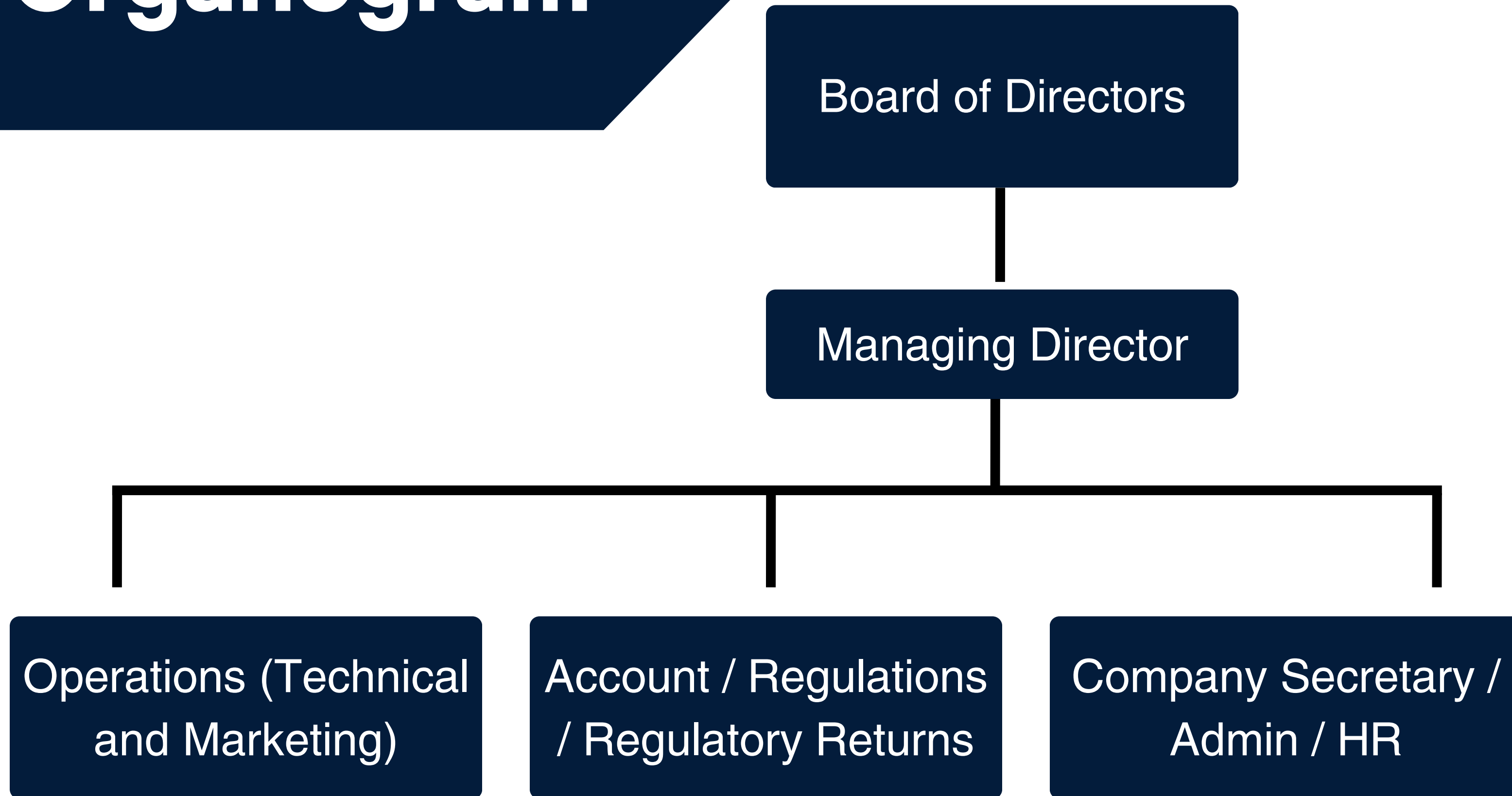


MIRACLE C. ANOZIE
